On 8 March 2024, CXM Pty Ltd (**CXM**) (a wholly-owned subsidiary of the Company) received \$2 million¹ as part consideration on the termination of the Orion Royalty² in relation to the Paulsens East Iron Ore Project (with \$3 million receivable on 30 June 2024)³.

By way of background, Orion refers to its market announcement of 3 January 2024 entitled "5 Million Receivable on Termination of Iron Ore Royalty Entitlement" whereby the Company announced that CXM had agreed to terminate and provide releases under the Orion Royalty in relation to the Paulsens East Iron Ore Project (located in the Pilbara, Western Australia), which Strike Resources Limited (ASX:SRK) (Strike) had entered into an agreement to sell to Miracle Iron Holdings Pty Ltd (Miracle)⁴, in consideration of Miracle agreeing to pay \$2 million to CXM on completion of the sale⁵ (with a further \$3 million payment deferred to 30 June 2024).

The \$5 million cash consideration is equivalent to approximately 32 cents (pre-tax) and 22 cents (post-tax, assuming a tax rate of 30% applies and prior to utilisation of any prior year tax losses) per Orion share based on Orion's 15,649,228 shares on issue. Orion will recognised the \$3 million deferred consideration component as a Receivable asset.

^{*} Orion notes that the carrying value of its 20,513,783 shareholding in Bentley is based on 'equity accounting' for Bentley as an associate entity – as set out in Note (1) over the page, this manner of accounting has technically reduced the carrying value to Nil – whereas this compares with Bentley's last closing price on ASX of \$0.04 per share (valuing Orion's investment at \$0.82 m) and Bentley's after-tax NTA value of \$0.0285 per share (valuing Orion's investment based on Bentley's NTA backing at \$0.585m), as at 29 February 2024.

Notes:

(1) The Company's investment in Bentley Capital Limited (ASX:**BEL**), an Associated Entity (i.e. in which the Company has a greater than 20% interest), is accounted for under the equity method in the consolidated financial statements. Under the equity method, the carrying amount of such investment is cost plus a share of the Associate Entity's net profit or loss (after tax) for the financial year to month end as provided to the Company by such Associated Entity. Refer also Note 19 (Investments in Associates) on pages 36 and 37 of the Company's 30 June 2023 Annual Report for further details in this regard.

Under the equity method of accounting for Associate entities, the Company's carrying value of its investment in BEL has been reduced from cost to nil – as a consequence of the Company's accumulated recognition of BEL's net losses. The Company is not required to carry the BEL investment at a negative value (ie. below Nil) and if BEL should generate net profits in the future, the Company will recognise a share of BEL's net profits under the equity method, which will permit the Company to recognise a positive carrying value for BEL.

Accordingly, as at 29 February 2024, the Company's 20,513,783 shares (26.95% interest) (31 January 2024: 20,513,783 shares and 26.95%) in BEL have a nil carrying value; this compares with BEL's last closing price on ASX of 4 cents⁶ per share (\$0.821m) and BEL's after-tax NTA backing of \$0.0285 per share (\$0.585m)⁷, as at month end.

- (2) The fair value of investments in ASX-listed Strike Resources Limited (ASX:SRK) comprise 10,000,000 shares (31 January 2024: 10,000,000 shares) with a value of \$0.05 per share (based on the closing bid price as at 29 February 2024) (31 January 2024: \$0.04).
- (3) The fair value of investments in other listed securities is based on each security's last bid price on market at month end.
- (4) Investment in property (held for resale) was valued by an independent qualified licensed valuer of the Australian Property Institute as at 30 June 2023.
- (5) Tax Provision Item (c) includes where applicable, a provision for income tax on net unrealised gains on the Company's investments in securities and its share of Associated Entities' after-tax net profit for the month (deferred tax liability) and the recognition of future income tax benefits on net unrealised losses on the Company's investments in securities and its share of Associated Entities' after-tax net loss for the month (deferred tax asset).
